Happy Friday! I trust everyone had a good Thanksgiving. I'm amazed that we all spend several days cooking and cleaning to prepare a meal that lasts 27-minutes. It is hard to believe the Holiday Season is already upon us and there are only 19 days left until Christmas. The City staff and work crews have been preparing for Festival of Lights this week with Christmas decorations being put up at the Rec Center, Library, City Hall, and the PD. Special thanks to the Electric Department for stringing lights on Main Street and on most City facilities.

Approximately 400 extras participated in a 4<sup>th</sup> of July parade scene filmed on Main Street last week as part of the Amazon Studio TV series "PANIC". The production company will not be returning to Smithville until after the first of the year. Since October, the production company (Picrow Streaming, Inc.) has spent approximately **\$150k** in our community on film permits, building rentals, business interruption fees, food, gas, and charitable donations. They have also hired local contractors and paid local talent (as extras) in support of the production. Although inconvenient at times, the production has definitely given our community an economic boost. The production company will be filming in Smithville off and on through March 2020.


Here is a list of significant accomplishments, issues, events, and activities since my last update:

1) FEMA Hazard Mitigation Grant (HMG) DR-4245 - Marburger Drainage Improvement Project Update - The Union Pacific Railroad (UPRR) FINALLY approved the plans for the Marburger drainage improvement project that were submitted in September 2018....14-months ago. If you recall, the City applied for (and was awarded) a \$140k FEMA Hazard Mitigation Grant (HMG) for drainage improvements on and around Marburger Street shortly after the October 2015 flood event. The existing terrain on Marburger and NE 1st Street is extremely flat and numerous homes have flooded over the past several years. The primary means of storm water collection is through a combination of open ditches (there is no curb and gutter in this area) and a shallow underground storm sewer system that feeds into an existing ditch located parallel to the railroad tracks. This ditch begins at Marburger Street and extends east approximately 5,900 feet where it outfalls into Willow Creek. The 1300 linear foot concrete valley gutter we plan to install to provide drainage relief on Marburger is in the UPRR Right-Of-Way (ROW) which required their sign-off. Numerous requests were made over the 14-month period to expedite the review and approval of the engineering design to no avail. As a result, the City had to request a 6-month project extension with FEMA to avoid de-obligation of funding. Bottom line, we are finally in a position to publish a Request for Proposal (RFP) to identify a construction contractor and start the project with estimated completion by July 2020.

- 2) Gazley Creek Bridge / 4<sup>th</sup> Avenue Road Closure The off-system bridge at 4th Avenue over Gazley Creek was ordered CLOSED for public safety by the Texas Department of Transportation (TXDOT) at 10:25 am on November 20, 2019. The City has been closely monitoring the condition of the Gazley Creek bridge (built in 1936) since Hurricane Harvey and requested a TXDOT inspection team evaluate the structural integrity after noticeable surface deformation was identified (SEE PHOTOS). TXDOT's team of structural engineers believe that the bridge's deterioration rate is unpredictable making the structural integrity "questionable". As such, the structure was deemed unsafe and immediately closed for public safety. A traffic detour via Live Oak at FM 2571 was established. Notices of the bridge / road closure and detour route were hand-delivered to residents who live on the "Hill" within 2-hours of the ordered closure. In addition, notices were posted on the City website and Facebook page. The City worked with the Smithville ISD to ensure this information was communicated to those parents with school-aged children on the Hill that ride the school bus. The City is currently working with TXDOT to identify an engineering solution that will most likely require the bridge to be replaced. The City is also working with the Union Pacific Railroad (UPRR) to ensure that the Live Oak crossing remain open to allow emergency services access to/from the Hill. Lastly, the City is seeking emergency funding assistance from the Texas Department of Emergency Management (TDEM) to cover the estimated \$1.3M bridge replacement cost. - 3) <u>2020 LCRA "Steps Forward Day" Project Application Submitted</u> The City of Smithville submitted the 2020 "Steps Forward Day" project application(s) to the Lower Colorado River Authority (LCRA) for consideration. Volunteers from LCRA will gather on Friday, April 3, 2020, to work on community projects throughout LCRA's service territory. Examples of potential projects include cleaning parks, painting pavilions, planting trees or doing carpentry work. Last year, LCRA volunteers painted fifty (50) ornamental light poles on Main Street and NW 1st around the Gazebo area. The volunteers also painted the steps and handicap ramp on the Gazebo. This year (if selected), LCRA volunteers will help the Smithville Community Gardens paint the interior and exterior of the city-owned facility located on SE 2<sup>nd</sup> street (the old Food Pantry). They will also paint all of the raised cinder block planting beds. The City also submitted an alternate project to paint curbs and parking spaces at the Smithville PD. The City will provide the equipment and tools necessary to support the project with LCRA providing the manpower (20-25 volunteers who will work 4-6 hours).
- 4) <u>Residential Cost Per Kilowatt Hour (kWh) Calculated</u> An analysis of LCRA billing data was conducted to determine residential cost per kilowatt hour (kWh) in DECEMBER. LCRA fuel costs vary month to month and are based upon electric utility generation, transmission, line loss, and service fees. The LCRA fuel cost per kWh for December is \$0.0675. This represents a 30.4% INCREASE in fuel cost compared to November's fuel cost of \$0.0517. Adding City's distribution fee of \$0.0500 and LCRA's \$0.0675 fuel cost, the cost per kWh for residential service in Smithville during DECEMBER will be \$0.1175 per kWh. Below you will find a "rolling" 12-month residential cost per kWh and a fuel cost comparison chart. On average, the cost per kWh for residential electric service in Smithville is between 11-12 cents with the typical household using 1,200 kW per month at a cost of \$144. - 5) <u>St. David's Foundation "Parks With a Purpose" Grant Awarded for MLK Park</u> The St. David's Foundation has awarded Smithville with a \$100,000 grant for outdoor fitness equipment, sunshade, a water fountain, an adult/child swing, and swing designed for wheelchairs, as well as funding for program "Activation" through a partnership with the SISD ACE After School program. The goal of this project is to provide new all-abilities, inter-generational playground equipment, and more opportunities to encourage the community to go to MLK park for healthy activities outside. This 12-month project will begin in early January.
- 6) <u>Texas Parks & Wildlife Department Grant Application Submitted for Keilberg Park</u> The City submitted another Parks program request to the Texas Parks and Wildlife Department (TPWD) for \$132,000 which would pay for improvements to Keilberg Park. This includes an all-abilities playscape and intergenerational playground equipment as well as outdoor fitness equipment, upgrades to the CCC-built concession stand to include an ADA-compliant restroom, and a water fountain that will serve a person standing, a person in a wheelchair, and a dog. Additionally, City crews and volunteers will clear the brush and poison ivy out of the wooded area so that the SISD ACE After School program can provide additional "Activation" programming. In addition, the City crews will improve the gravel parking lot area. We will be notified this spring whether we would be awarded this 12-month grant, which would begin in May, 2020.
- 7) FEMA Hazard Mitigation Grant (HMG) DR-4272 Project Kick-Off Meeting After the 2016 Memorial Day flood, the City applied for and received a \$688k FEMA Hazard Mitigation Grant (HMG) to upgrade drainage lines on SE 2<sup>nd</sup> Street and construct a detention pond behind the City Warehouse located at 1000 MLK Drive. The 1.5-acre detention pond will hold approximately 3.5M gallons of water that will help alleviate flooding at the City Warehouse and along SE 2<sup>nd</sup> Street. Both the detention pond and new storm water collection system has been sized to mitigate up to the 10-year, 24-hour storm event. On 12/5/19, the City staff met with representatives from the Texas Department of Emergency Management (TDEM), Langford Community Management Services (LCMS), and Cohn-Resnick for a project kick-off meeting. The purpose of the meeting was to discuss the grant terms and conditions, review procurement guidelines, verify City match, and identify the construction timeline. The project match requirement is 25% of the total grant amount or \$172k. The City match is a budgeted expense that will be paid using dedicated C of O funds. The next step is to prepare bid documents and publish a Request for Proposal (RFP) so that a construction contractor can be selected by the Council. The target completion date for this project is on or before February 9, 2021.



### DR-4272 - SE 2<sup>nd</sup> Street Drainage Improvement Project

The **29th Annual Festival of Lights** and the Lighted Parade is on **Saturday, December 7th** from 10am-9pm. This event has grown every year and the Chamber expects a record crowd will be attending the parade. The Gazebo lighting will be at 6:30 p.m. and parade begins at 7:00 p.m. This year, no city officials will be riding in the parade. However, councilmembers should plan to attend the lighting of the Gazebo with the Mayor. Come enjoy live music, food vendors, kid's activities, and photos with Santa (sponsored by the Smithville Police Department).

The **Smithville Public Library** will be holding an Open House on **Thursday, December 12<sup>th</sup>** (from 4:00 - 6:30 pm)

The annual **Smithville Volunteer Fire Department (SVFD) Christmas Party** will be held on **Friday, December 6th** at the Pavilion in Riverbend Park. Social starts at 6:00 p.m. with Dinner at 7:00 pm. Councilmembers are welcome and encouraged to attend.

The City will be holding a **Holiday Open House** (all day) at City Hall on **Tuesday, December 10<sup>th</sup>** ...nothing fancy but we will have cookies, punch, and cider during the day. The public is welcome to attend.


