


City Council open seat appointment

Ladies and Gentlemen:

I see that the Smithville City Council has decided to use Local Government Code 22.010(a) to fill the vacancy created when Cassie Barrrientos recently resigned. The key in this code is "may fill the vacancy by appointment."

The timing of this is very concerning. I actually spoke with Ms. Barrientos this past February at a mutual friend's child's Birthday Party. She informed me that the resignation had not yet been made, but her comments indicated that it was a done deal. I applied her for her efforts; however, I have to question why she decided to run in the last election. Then, after the unfortunate medical problems with her new baby, she really should have stepped down months ago — when there was time for a special election.

Now we conveniently have a situation where many people – whom I might add – did not actually run for the office - or any office for that matter, are now applying for the appointment. Even more concerning, there is a former City Council Member (as well Former Mayor) who is being considered, again – AFTER stepping down twice in the last couple of years! I find this behavior unprofessional. If you so want the job, keep running.

The disregard of the Smithville Voters and Citizens is an ongoing problem. Vacancies arise on the City Council and an appointment is made.... This "quick and dirty" method hides the true issue at hand - the dismal voter turnout and lack of Candidates that will run for a City Office. I have to question why this is?

Dear Council Members, Ms. Mayor and Mr. City Manager:

I would like to address the upcoming selection of the city council seat for the vacated seat by Cassie Barrientos.

I strongly believe that the only two people that should be considered for the vacated seat are Monica Poss and Mitchell Jamison. I believe **Mitchell Jamison** should be placed in the open seat. He and Tyrone ran a very close race — closer than the race between Jimmy Jenkins and Monica Poss.

Monica Poss and Mitchell Jamison have put in the time and effort and shown their commitment to fulfill the obligations of these available seats. I urge the council to vote for Mitchell Jamison to occupy the seat vacated by Cassie Barrientos.
