Discussion and Action on the awarding of a contract bid for the Marburger Drainage Improvements project (FEMA DR-4245-012 project):. The bid opening for the Marburger drainage improvement project (HMG DR-4245) was held at 10:00 am on Tuesday, February 4, 2020 at City Hall. The project involves the installation of a 1300 linear foot concrete valley gutter to provide drainage relief on Marburger and NE 1st street. Five (5) contractors submitted base bids ranging from \$135k to \$275k with 304 Construction, LLC submitting the lowest bid at \$135,079.00. The estimated construction start date is March 27, 2020 and the project will take 60-90 days to complete. Councilwoman Foerster made a motion to award the contract to 304 Construction L.L.C. Councilman Jason seconded and the motion passed unanimously.

Discussion and Action on the Financial Report: Councilwoman Foerster made a motion to approve the Financial Report. Councilman Gordon seconded and the motion passed unanimously.
